### COURSE #1

# \*\*New\*\* LABOUR LAW: SWIMMING IN THE "SEA"

Juliana Saxberg, CUPE National Legal and Legislative Representative (Regina) & Suzanne Posyniak, CUPE National Representative (Regina)

This course will focus on the legal framework for union recognition and collective agreement administration under *The Saskatchewan Employment Act* ("SEA"), proclaimed into law on April 29, 2014.

Participants will learn about significant changes from the former *Trade Union* Act (now Part VI of *The SEA*) and the potential impact of such changes on their workplaces. Other labour relations topics such as Employment Standards (now Part II of *The SEA*) and Occupational Health and Safety (now part III of *The SEA*) will be discussed in the context of the new legislation.

There will be a focus on essential services (now Part VII of *The SEA*) and the highly anticipated decision from the Supreme Court of Canada in *Saskatchewan Federation of Labour v. Saskatchewan*, where Saskatchewan trade union organizations argued that Saskatchewan's essential services legislation violates a constitutionally protected right to strike.

Please note that this course is tailored to the more experienced member who has some familiarity with legislation affecting unionized workers.

There are a lot of changes happening in our province and in our union.

Public services and unions are under attack. The government is pushing an agenda of privatization, weaker labour laws and increased power for employers and corporations. There are also two major elections (federal and provincial) coming soon and the outcome could impact our members greatly.

We know that when public services decline, the result is more inequality in society. Our public services benefit everyone in society and ensure equal access to quality services. When public services are privatized, costs increase and the services are no longer accessible to all.

Declining union power also results in more inequality. Unions have fought for fair wages and benefits, safe working conditions and quality public services. Jurisdictions with fewer unions have more inequality, more poverty, and substandard working conditions.

In this workshop, members will learn skills to engage members and our allies in our communities. We use these techniques within our political action framework to achieve our goal for positive change for CUPE members and for people in our communities. This is an exciting chance to build your skills to help build a movement for progressive change.

### Passage to Fortune:

This tour begins in the late 1800s with the completion of the Canadian Pacific Railway in British Columbia. It follows the story of a fictional Chinese immigrant, Mah Lee, from his home in China to his eventual home in Canada. Guests see the challenges experienced by early Chinese immigrants, their unfair treatment by government and their ultimate acceptance. Some of the topics covered are:

- Construction of the Canadian Pacific Railway
- Conditions in China that led to migration
- Coolie brokerage
- The Head Tax and the 1923 Chinese Immigration Act
- Racism
- Construction and uses of the tunnels

Guests are invited into Miss Fanny's Club but soon find themselves underground with Gus, one of Capone's henchmen, running from the law and maybe into trouble. Some of the topics covered are:

- Bootlegging
- Prohibition
- The rise and fall of Al Capone
- American gangsters
- Moose Jaw in the 1920s
