Saskatchewan wage top-up doesn't go far enough, Application process not yet clear

The Saskatchewan government announced on April 30 a wage top-up for some frontline workers during the COVID-19 pandemic, but CUPE Saskatchewan has concerns.

The government subsidy, which is mostly funded by the federal government, will provide \$400 a month for three months, retroactive to March 15. Only workers in the following facilities are eligible:

- Senior-care facilities, including private care homes and home care;
- Licensed childcare facilities;

- Group homes run by community-based organizations; and
- Emergency shelters and transitional shelters.

CUPE is calling for additional funding to support front-line staff that are not covered by the current announcement and working to ensure all workers have access to proper personal protective equipment.

Judy Henley elected president of CUPE Saskatchewan; vows to keep up the fight for public services



Judy Henley, a health care worker and member of CUPE Local 5430 from Melville, was elected as the new president of CUPE Saskatchewan at the 2020 annual convention.

Henley has been active in CUPE since 1985. In that time, she has served in many leadership roles within CUPE at the local, provincial, and national levels. Since 2000, Henley has served as secretary-treasurer of CUPE Saskatchewan. Driven by a passion for the rights of workers to retire with dignity and her conviction that all workers should have access to good benefits and injury compensation, she remains an active member of the CUPE Local 5430 Pension and Benefits Committee and subcommittees with the employer.

"I am humbled by the support. I will be working hard to represent our members," said Henley as she accepted her new role.

Tom Graham first became involved in CUPE in 1979 when he was hired by the City of Saskatoon Sign and Paint Shop. He was elected President of CUPE Local 859 (Saskatoon Municipal Workers) from 1996 – 2004 and served as the union's provincial president since 1998. Tom also served several successive terms as a National General Vice-President and Regional Vice-President of CUPE.
