

# STANDING COMMITTEE APPLICATION FOR APPOINTMENT



The Saskatchewan Division of the Canadian Union of Public Employees (CUPE Saskatchewan) is currently accepting applications from members of affiliated Local Unions to serve on standing committees. Appointments are made in odd-numbered years and/or at any time to fill a vacant position. Appointed members serve up to a maximum two-year term, or shorter term of a specified length to fill a position resulting from a vacancy.

**To be eligible for appointment, you must be a member in good standing of a Local Union affiliated to CUPE Saskatchewan.** Members shall only be eligible to sit on one committee at any given time. Consideration will be given to members who were delegates at the most recent Annual Convention. Standing committees work on a specific policy and program area, advising and making recommendations to the Executive Board. Committees are governed by *The CUPE Saskatchewan Constitution & Bylaws*.
